### 4. NAWPC / WWPI / SPTA

T.Ladoux from the Western Wood Preservers Institute provided an update on their activities to the WPC members. WWPI emerging issues are:

- Montana Eligible Renewable Resources.
- USA Corps of Engineers Regional Conditions.
- WSDOT Guardrail Policy
- Washington State Proposed Taxes Initiatives.

T.Ladoux, K.Ragon and D.Brooks gave an update of the current and planned activities of the NAWPC, of which Wood Preservation Canada is an active member with the Western Wood Preservers Institute, and the Southern Pressure Treaters Association. NAWPC has a 2013 budget of \$216,400.

National Electrical Safety Code Emerging Issue

- Movement within NESC to incorporate a true Load and Resistance Factor (LRFD) design basis that favors alternative materials.
- NAWPC has developed a multi-year strategy to deal with issue.
- The multi-year strategy and proposed work plan should be done in four year with an estimated budget of \$193,500 over four years.
  The work plan will need supplemental funding from WWPI, SPTA, WPC.

T.Ladoux and R.Ragon informed the members on multiple legislative issues that they have dealt with and their status. They also presented the Pole Fire Performance Project. D.Brooks updated the members the Overhead Wood Pole Structure Design Seminar, Wood Pole Standard Workshop and the EUI Hosted Webinar Seminars that are organized and coordinated by NAWPC and WWPI.
