4. Update on Cecobois and QFIC Activities

- L. Poliquin, director of Cecobois gave an update to the members on the activities of Cecobois and the Quebec Forest Industry Council (QFIC).
- L. Poliquin mentioned during his presentation that the Quebec forest industry sector accounted for 60,906 jobs in 2012. In 2012, 20% of the softwood lumber produced in Canada came from the province of Quebec.

He also talked of the history of the wood movement in Quebec and elaborated on the Wood Charter. The key aspects of the wood charter, is that wood must be considered and evaluated at the preliminary stage for all new buildings funded by the government. A comparative analysis of carbon footprint must also be completed. L. Poliquin finished the presentation with pictures of different wood projects in Quebec.
