BILL C-45

Bill C45 is an act to amend the Criminal Code (criminal liability of organizations). It imposes legal duty on employers, those who direct work and especially senior officers. Those mentioned must ensure the safety of workers and the environment.

The current law states that a corporation may be considered guilty if its 'directing mind' committed the prohibited act and had the necessary guilty state of mind. To help determine who is sufficiently important within an organization to be considered its directing mind, Bill C-45 includes a definition for senior officer

described as everyone who has an important role in: setting policy (which is the current Canadian law); or anyone managing an important part of the organizations activities (which is new).

This new definition makes it clear that the directors, CEO and CFO of a corporation are all by virtue of the position automatically considered "senior officers".

60 day period to comment on Re-evaluation of CCA Wood Preservative.

March 17th 2004 PMRA released re-evaluation note, REV2004-01: Update on the Re-evaluation of CCA Heavy Duty Wood Preservative. The purpose of the note is to inform interested parties on the current status of CCA in Canada, particularly health risk assessment for workers in pressure treatment facilities and risks to the environment. A final risk assessment will be released later in 2004, comments are accepted for 60 days. CITW is working with the CCA registrants and the Arsenic Task Force, American Chemistry Council to ensure

comments are submitted on behalf of the industry.

60 day period to comment on Export / Import of Hazardous Waste and **Hazardous Recyclable Material Regulations**

The Proposed Export and Import of Hazardous Waste and Hazardous Recyclable Material Regulations (proposed regulations) under the Canadian Environmental Protection Act. 1999(CEPA 1999) were published in the March 20 2004 edition of Canada Gazette Part 1. Comment period is open for 60 days.

The regulations will revoke and replace the Export and Import of Hazardous Wastes **Regulations (EIHWR)** adopted in 1992 under the authority of the former CEPA Act, revise existing EIHWR obligations and introduce new elements including, but not limited to: Separate definitions for hazardous waste and hazardous recyclable material. Specific time periods for completing disposal or recycling operations once hazardous wastes or hazardous recyclable materials are accepted at authorized facilities. Criteria the minister will take into account prior to refusing to

issue an export, import and transit permit, to determine if represent our objections to the hazardous waste or hazardous recyclable material will be managed in a way that will protect the environment and human health and facilitation of recycling. This is done by excluding from the definition of hazardous recyclable material certain low-risk recyclable materials, and by extending the \$1-million liability insurance requirement for Canadian importers and Canadian exporters to movements of hazardous recyclable materials.

The proposed regulations maintain the same core framework of the existing EIHWR, however the language, structure and proposed regulations are quite different to provide more clarity regarding legal requirements.

Under the proposed regulations. industrial/commercial treated report on: wood waste will be designated as hazardous. Herb Estreicher, Keller & Heckman is assisting CITW to develop a submission and possible objection to the Minister. CITW is also working with the Canadian Electricity Association, CN and CP railways, Bell Canada, Canadian Wood Council and Natural

Resources Canada to the regulation. We have also received assistance from Dennis Havward of the Western Wood Preservers Institute regarding current practice in the U.S west coast.

BMO raises standards for environmental risk disclosure

The Bank of Montreal's (BMO) shareholders voted 90.9 percent at the recent annual meeting in favor of a resolution asking the bank to disclose how it evaluates and manages environmental risks to its business. According to **Real Assets Investment** Management Inc. (RAIM), the vote is one of the strongest majorities ever recorded in Canada for shareholder resolution dealing with social or environmental issues. Real Assets was the lead filer of the shareholder resolution which called on the bank to

- 1) The environmental criteria it uses: and
- 2) The precautions the bank is taking to ensure that credit is provided only to companies that meet environmental standards.

Keith Knowling appointed CEO of Ram Forest Group Inc.
