PMRA Heavy Duty Wood Preservative Re-Evaluation

On June 22nd, 2011 the Pest Management Regulatory Agency posted the Re-evaluation Decision for the heavy duty wood preservatives (Creosote, Pentachlorophenol, CCA, ACZA) on their website. The link below will bring you to the posting.

Ontario Toxics Reduction Act

The first stage of requirements outlined in the Toxics Reductions Act has come and gone. The Ontario Minstry of Environment (MOE) required NPRI reporting be submitted by Ontario treaters to the MOE by June 17th 2011.

WPC has initiated communications with the MOE to explain the accomplishments made via the implementation of the TRD's and our certification program. We are still hoping to get the CWPCA program recognized by the MOE.

WPC will be working with WESA and the CWPCA Steering committee to prepare an information package to submit to the MOE showcasing the CWPCA Certification program in the coming weeks.
