#### 1. CALL TO ORDER

## 4. FINANCIAL REPORT/BUDGET

The financial report for the year ending December 31, 2002 was presented and the Budget and Plan for 2003 was briefed. H. Walthert mentioned that expenses slightly exceed revenues, but plans are to absorb the extra expense by the end of 2003. The auditors noted that nothing unusual appeared in the financial statements.

### 5. ANNUAL REPORT

Henry Walthert reported on the 2002 program and noted that we had three new memberships last year. He gave a detailed presentation on the transition into new preservatives including CSA standards.

H. Walthert presented two news clip videos from CNN and Global News that reported on the recent EDC (Environment Defence Canada) study involving play structures treated with CCA to reflect the media's position. He added that it was worth noting that we as an industry did not receive considerable negative attention from the media, thought to be because the study was flawed and the reports are on old news.

## 7. CANADIAN WOOD COUNCIL REPORT

Mary-Anne Dalkowski, CITW's representative on the CWC Board of Directors, reported on the activities of the CWC. She noted CITW's participation in the Wood Solutions Fairs, recommending continuing participation as good value for money as the Wood Solutions Fair contributes 20,000 hours to education & promotion. Commented that the Wood Council does not always represent our exact interests, however, they are open to discussion so we must keep an open communication system with them.

The transition to new preservatives will affect the National Building Code (NBC) and the NBC wants treated wood to be marked.

Noted that Canada Mortgage and Housing Corporation (CMHC) has published research on moisture meters. Sites of interest are: <u>www.durable-wood.com</u> and <u>www.woodinsight.com</u>.

The CWC's annual report highlighted governance and the need to set goals. Suggestions for additional sources of revenue included publications (put on hold for new products).
