1. CALL TO ORDER

Chairman P. Dandy called the meeting of the Commercial/Industrial committee to order at 08:40.

2. ADOPTION OF AGENDA

3. ADOPTION OF MINUTES

4. CSA POLE STANDARD

Update from B. Lucas: The CSA 080.05 standard is up for review. The Technical Committee has approved it; it is a matter of time before it is published (probably next year).

5. CCA Industrial Applications Strategy

- H. Walthert noted that the Industrial Strategy was not implemented because of confusion in the marketplace. The intent of the strategy was to support CCA in the commercial/industrial market; however, uncertainties regarding overlap between industrial products going into the residential market caused some concern & confusion. NOTED
- P. Dandy noted CITW and the Industry need to clarify CCA issues for end users. He posted a vote of confidence for CITW to move forward with the Industrial/Commercial strategy. Volunteers to help implement the strategy include: C. Frohlich, C. Baker, P. Dandy, T. Fitzgerald, and G. Stein. NOTED
- T. Fitzgerald briefed the committee on new information from the EPA on the reregistration process. In the U.S., CCA will continue to be used in the following residential applications: Shingles/Shakes, Permanent Wood Foundations, and Utility/agricultural posts.

6. ZINC LEACHING STUDY

H. Walthert noted that there isn't anything new to report. The study is confidential and cannot be published.

7. NORTH AMERICAN WOOD POLE COALITION (COUNCIL)

The Coalition is now Council. The Council is marketing and promotional oriented and not regulatory. H. Walthert presented that CITW's share has risen from 10% to 13%. The NAWPC will have three board members from each of its members (WWPI, SPTA, CITW).
